Fisherfolk in St. Vincent and Grenadines Petitions government for Gas Rebate or Concession

At present with the high gas prices, SVG fisherfolk cannot meet their expenses and will eventually be forced to raise fish prices. Between January 2021 to present, gas prices in SVG have risen 8 times.

At the start of 2021, gas was XCD\$10.50 per gallon; gas prices are now XCD\$14.72 per gallon. These increases have direct impacts on the cost of fishing for fishers. For example, in June/July 2021 fishers were spending approximately EC\$460 in gas on a normal day trip, but with the continued increases in gas prices, fishers are now paying approximately EC\$690 per trip.

A gas rebate or concession from the government will help to reduce the cost of fishing for fishers and subsequently ensure that fishers can bring fish to market to be sold at a reasonable and affordable price for consumers. - submitted by Winsbert Harry

SAINT LUCIA FISHERS AGGRIEVED OVER SECOND CLOSURE IN TWO YEARS OF MARKETING ENTITY

The fishing community has once again woken up to the news of the closure of the Fish Marketing Agency. Questions are rife as to how many times the same horse can die.

In 2019, after much talk about breathing new life into the then entity, St Lucia Fish Marketing Corporation, a new entity emerged, Lucian Blue Ocean Seafoods. This, despite numerous consultations with stakeholders and a promise to develop a public-private partnership with the suppliers of the raw materials-the fishers- through their representative body, St Lucia Fisherfolk Co-operative Society Limited. The emergence of this new entity was met with great doubt, uncertainty and in some instances resistance by an industry that was left uninformed about what this new entity was about, who owned it, what their mandate was, etc.

A little over two and a half years into its operations, the local media was piling up with headlines of the closure of the entity an eventuality that created fear and despondence throughout the fishing community. Days later, the Management of the entity issues a press release explaining that they are closed only temporarily to allow for them to make a few changes that they dub necessary for the survival of the company amid trying times. "Contrary to unverified reports broadcasted in recent times, the closure took effect after all staff and our fisher partners were duly informed. Our decision was not without due thought process. Our staff and stakeholders have always been front and center of all of our operational decisions."

It is often said that fishers are not respected despite their contribution to food security, GDP, etc. and this new reality is an indication, to them that nothing has really changed. Despite the fact that the management of that LBOS claimed that they were in dialogue with the stakeholders, many fishers have indicated otherwise. The issues are too important to point fingers and play games. What is irrefutable is that the main stake, is and has continued to be left out of the equation and discussion and there is no time than now to change that reality. Vocal fisherwoman and boat owner Ms. Dannie James had taken to the airwaves to, on behalf of the fishing community, express her displeasure on the events. More fishers need to stand up and speak up.

We implore the new administration under the leadership of the Minister for Agriculture, Fisheries, Rural Development and Food Security, Hon, Alfred Prospere to ensure that the needs of the fisher, their voice and their needs are not left behind hastily as the decisions are taken that will directly affect their livelihoods. Perhaps this is a time when regional integration and partnerships have to take effect in areas such as marketing as we cannot continue to be at the disposal and mercy of the political directorate or private entities who come with their own corporate agenda. The fishing industry is too important to continue to be taken for granted but it is really up to us as the players within the industry to do better, to be better and to demand better from the authorities. For now, the St Lucia Fisherfolk Co-operative Society will continue to make representation on behalf of those they serve to see to it that this matter is addressed in a manner that is most beneficial to the development and sustainability of the sector. We are hopeful that the need to give a seat at the table to the fisher, through its representative body, is recognized NOW. Submitted by Kaygianna Chalery

TWO CNFO YOUTH MEMBERS ATTENDING WFFP VIRTUAL YOUTH TRAINING






