
## **36th Committee on Fisheries (COFI)**

Committee on Fisheries, COFI36. The thirty-sixth session, was held from 8-12 July 2024 at FAO Headquarters, Rome, Italy. The session was convened in a hybrid modality. A safety at sea training commenced on the 23rd of September 2024 at the Fisheries Conference in St. Vincent and the Grenadines, aimed at enhancing participants' knowledge and preparedness to tackle challenges faced at sea.

## ST. VINCENT & GRENADINES

Hurricane Beryl (June/July 2024), which struck the Caribbean region, has had a devastating impact on the fishing communities of St. Vincent and the Grenadines. The local fisherfolk, who rely heavily on their catch for sustenance and income, have faced significant losses due to damage to boats, fishing gear, and infrastructure. WHYHUNGER supported the NFO with a small grant to purchase equipment.





Responding to the announcement that the Government may have to import fish, the President of the National Fisherfolk Organization- Winsbert Harry, expressed his disagreement with such a move.

While he acknowledges that low catch rates have been an ongoing issue, he believes more can be done to support local fishermen in increasing their catch. (SVG TV)

### **MONTSERRAT**

John Lee, an experienced fisher of Montserrat, set out alone on a white 23 feet fishing vessel, named the MV Optimum, at about 6.30am on 28 August. He was expected back to the island later that day, but has not been seen since. Extensive search was carried out to find him. He is still not found.

The Fisheries Department of Montserrat had a safety at sea training on the 28th August 2024 for the fisherfolk. Additionally, they issued some hand held radios to local fishers.

The Ministry of Agriculture discussed essential topics like safety at sea, radio operations, vessel registration, and port regulations.



Since September 2024 Mr. Dan Edwards is the new Chief Fisheries Officer for Montserrat.

### **CSFUND/TIDES**

January 9, 2024 **Tides** the Foundation. on recommendation of CSFund. gave the CNFO a grant of USD\$60,000.00. This grant is CNFO's for the Just Transitions. The arant period is from January 1, 2024, to December 31, 2026



On July 30, 2024, the Pan American Development Foundation (PADF) awarded CNFO a USD\$250,000 grant to implement a project entitled "USAID Caribbean Sustainable Ecosystems Activity." The grant period is from July 30, 2024, to September 30, 2027.
